

Examining Residential Land Use Conversion in Diobu, Port Harcourt, Rivers State, Nigeria

Abstract- This study examines the phenomenon of residential land use conversion in Diobu, Port Harcourt, Rivers State, Nigeria, focusing on the drivers, socio-economic impacts, and policy responses to the ongoing transformation of residential spaces. The rapid urbanization of Diobu, coupled with economic pressures, evolving community needs, and weak regulatory frameworks, has led to significant changes in land use, where residential areas are increasingly being repurposed for commercial, mixed-use, and industrial activities. This study employs a mixed-methods approach, including both qualitative and quantitative data collection, to analyze the factors driving residential land use conversion and to assess its consequences on housing affordability, community cohesion, local livelihoods, and infrastructure. The findings reveal that residential land use conversion in Diobu has exacerbated housing shortages, displaced lower-income residents, and placed additional strain on urban infrastructure, while fostering economic growth for developers and landowners. However, the lack of effective enforcement of zoning regulations and the absence of policies prioritizing affordable housing have worsened these impacts. Based on these findings, the study recommends strengthening urban planning regulations, promoting affordable housing initiatives, encouraging mixed-use developments with social equity considerations, and improving community engagement in the planning process. The study highlights the need for sustainable and inclusive urban development policies that balance economic growth with the preservation of affordable housing and community integrity, offering insights for urban planning practitioners and policymakers in Diobu and similar Nigerian urban contexts.

I. INTRODUCTION

Residential land use conversion represents a crucial aspect of urban development, with significant

implications for the socio-economic dynamics of communities globally. Within this context, the district of Diobu in Port Harcourt, Rivers State, Nigeria, serves as an important case study for investigating the processes and impacts of land use transformation (Nwokaeze & Uchendu, 2025). Diobu, a rapidly growing and dynamic urban area, has witnessed a marked increase in the conversion of residential land for commercial, industrial, and mixed-use purposes. This phenomenon is multifaceted, and its consequences extend far beyond the physical alterations to the urban landscape (Izeogu, 2018). The motivation for this research stems from the urgent need to understand and address the growing trend of residential land use conversion in Diobu. This shift, characterized by the transformation of residential spaces into commercial and mixed-use developments, presents critical challenges that demand attention. As residential areas are repurposed, several key questions arise, including the socio-economic consequences for the local population, the implications for land tenure systems, and the long-term sustainability of urban growth (Ibrahim, 2022).

The central focus of this study is to explore the complexities of residential land use conversion in Diobu, analyzing its drivers, consequences, and potential strategies for mitigating negative outcomes. This research adopts an interdisciplinary approach, integrating perspectives from urban planning, sociology, economics, and community studies, to provide a comprehensive understanding of the phenomenon. Understanding the drivers of residential land use conversion in Diobu is essential to formulating effective urban policies. Factors such as rapid urbanization, economic pressures, regulatory frameworks, and changing community needs are expected to play pivotal roles in this transformation

(Obinna et al., 2009). Investigating these drivers will help in developing strategies to promote sustainable urban development in Diobu and similar urban environments. Furthermore, this study examines the socio-economic impacts of residential land use conversion on the Diobu community. Key areas of focus include the availability and affordability of housing, community cohesion, livelihoods, infrastructure demands, and the overall quality of urban life. By analyzing empirical data, reviewing relevant literature, and incorporating local perspectives, this research aims to provide a nuanced understanding of the effects of land use changes in Diobu. In conclusion, this paper sought to offer a scholarly foundation for understanding and addressing the challenges associated with residential land use conversion in Diobu. Through the integration of empirical evidence and theoretical frameworks, it aims to inform policy interventions that promote sustainable urban development in Diobu and other comparable urban contexts.

1.1 Aim of The Study

The aim of this study was to examine the processes and dynamics of residential land use conversion in Diobu, Port Harcourt, Rivers State, Nigeria, with a focus on understanding the underlying drivers, socio-economic impacts, and policy implications. The study seeks to provide a comprehensive analysis that will inform urban planning strategies for managing land use transformations in the context of rapid urbanization.

1.2 Objectives of The Study

Based on the aim the following objectives were developed to:

1. identify the key drivers of residential land use conversion in Diobu, Port Harcourt.
2. assess the socio-economic impacts of residential land use conversion on the community in Diobu.
3. evaluate the effectiveness of urban planning policies and regulatory frameworks in managing residential land use conversion in Diobu.
4. investigate community perceptions of residential land use conversion and its impact on the quality of urban life in Diobu.

5. propose policy recommendations for sustainable land use management and urban planning in Diobu.

Based on the findings, this objective seeks to offer actionable recommendations for policymakers and urban planners to manage land use conversions in a way that balances economic growth with the preservation of affordable housing and community integrity

II. LITERATURE REVIEW

2.1 Theoretical Review

The theoretical foundations for understanding residential land use conversion in Diobu, Port Harcourt draw from Urban Land Use and Zoning; Mixed Land Use Planning; Land Value; Site Planning and Spatial Configuration and Urban Spatial Analysis Theories:

2.1.1 Urban Land Use and Zoning Theory

Stull's (1974) Urban Land Use and Zoning Theory provides a foundational lens for understanding residential land use conversion in Diobu. The theory posits that land use patterns are shaped primarily by market forces, where landowners gravitate toward uses that promise higher economic returns. It also emphasizes that zoning regulations either constrain or enable such shifts, with weak or flexible regulatory enforcement accelerating unplanned land use transitions. In the context of Diobu, these tenets suggest that increasing commercial demand, coupled with lax zoning control, stimulates the conversion of residential properties into commercial or mixed-use spaces as property owners pursue greater profitability.

2.1.2 Mixed Land Use Planning Theory

Raman and Roy's (2019) Mixed Land Use Planning Theory further explains the dynamics of land use change in rapidly urbanizing environments. The theory argues that dense urban areas naturally evolve toward mixed uses as population growth and economic diversification intensify. It also maintains that functional integration improves urban efficiency by reducing travel demand, supporting livelihoods, and promoting socio-economic diversity. These principles illuminate why Diobu, characterized by

high population density and intense economic activity, experiences significant residential-to-commercial conversions, as its urban structure inherently supports mixed-use development.

2.1.3 Site Planning And Spatial Configuration Theory

Lim and Kang (2022) highlight how site planning and spatial configuration influence the adaptability and sustainability of residential areas. Their theory asserts that inefficient physical layouts can diminish residential suitability, triggering redevelopment or informal conversions. Furthermore, poor spatial design undermines livability and increases the tendency for buildings to shift toward more lucrative uses. In Diobu, congestion, inadequate utilities, and weak planning standards create conditions that reduce residential comfort, thereby motivating property owners to convert dwellings into commercial establishments that offer higher returns.

2.1.4 Land Value And Urban Spatial Analysis Theory

Topcu and Kubat's (2009) Land Value and Urban Spatial Analysis Theory also provides critical insight into land use conversion. The theory maintains that accessibility and connectivity significantly shape land values, with highly connected urban zones attracting non-residential uses. It emphasizes that urban features—such as road networks, service proximity, and density—affect market behavior and encourage landowners to maximize value through functional changes. Applied to Diobu, these principles explain how its strategic connectivity and heavy commercial traffic elevate land values, incentivizing the transformation of residential properties into business spaces to capitalize on emerging market opportunities.

The theoretical foundation for examining residential land use conversion in Diobu draws from Stull's zoning theory, which links weak regulation and market incentives to shifts in land use; Raman and Roy's mixed land use theory, which explains how dense urban areas naturally evolve toward commercial-residential blends; Lim and Kang's site planning theory, showing how poor spatial design encourages adaptive reuse; and Topcu and Kubat's land value theory, emphasizing how accessibility

drives conversion. These theories are vital to the study because they collectively clarify the economic, spatial, and regulatory forces shaping Diobu's transformation, guiding analysis and informing planning interventions.

III. CONCEPTUAL REVIEW

2.2.1 Residential Land Use

Residential land use conversion is a key topic within urban studies, given its significant implications for urban sustainability, community well-being, and socio-economic structures. In Diobu, Port Harcourt, Rivers State, the trend of converting residential land for non-residential purposes has spurred academic inquiry aimed at understanding its causes, consequences, and broader impacts.

2.2.2 Drivers of Residential Land Use Conversion

The literature identifies several key factors driving residential land use conversion in urban areas similar to Diobu. Rapid urbanization is frequently cited as a primary driver, as growing populations increase demand for land to support diverse economic activities (Russell-Smith et al., 2018). Economic factors, such as market dynamics, investment opportunities, and profit-driven motives, also contribute significantly to the conversion of residential properties into commercial and mixed-use spaces (Mannan, 2024). Additionally, regulatory frameworks, land governance systems, and evolving community needs play crucial roles in shaping the patterns of land use change (Nguyen, Agbola & Choi, 2019).

2.2.3 Implications and Consequences

The consequences of residential land use conversion are far-reaching. Studies indicate that such transformations place considerable strain on housing availability, often exacerbating spatial inequalities and contributing to housing shortages for vulnerable populations (Ikiriko & Gbarabe, 2024). Moreover, alterations in land use patterns can disrupt community cohesion, alter cultural identities, and impact the social dynamics within neighborhoods (Onwuanyi & Oyetunji, 2021). Furthermore, the increased demand for infrastructure—such as utilities, roads, and transportation networks—poses

significant challenges for urban planners and local governments (Ayo-Odifiri et al., 2021).

2.2.4 Mitigation Strategies and Policy Interventions

Several scholars have emphasized the need for comprehensive mitigation strategies and policy interventions to address the challenges posed by residential land use conversion. Integrated urban planning approaches that incorporate community participation, adaptive land governance frameworks, and policies promoting sustainable land use are considered essential for managing the complexities of land conversion (Zakari, 2022). Furthermore, sustainable development policies that prioritize affordable housing, land tenure security, and equitable urban growth are critical to minimizing the negative effects of land use changes (Umeh & Ezeji, 2023).

2.3 Summary of the Literature Review

The literature shows that residential land use conversion is driven by rapid urbanization, economic pressures, weak regulatory frameworks, and changing community needs in cities similar to Diobu. Scholars highlight that such conversions reduce housing availability, displace low-income groups, strain infrastructure, and weaken community cohesion (Ikiriko & Gbarabe, 2024; Onwuanyi & Oyetunji, 2021). Economic incentives, market-driven development, and poor site planning further encourage the transformation of residential spaces into commercial and mixed uses. Although mixed-use development can stimulate economic growth, the absence of strong planning regulations and affordable housing policies exacerbates social inequities. Overall, past studies emphasize the need for stronger governance, inclusive planning, and sustainable land use policies to manage such urban transitions.

Despite extensive studies on land use conversion, three main gaps remain:

- i. Limited empirical research specifically focused on Diobu, despite its rapid urban change.
- ii. Insufficient integration of community perceptions, as most studies focus on planners

and developers rather than residents most affected by conversion.

- iii. Weak analysis of policy effectiveness in regulating land use conversions in Port Harcourt, leaving gaps in understanding how planning failures contribute to the problem.

This study fills these gaps by using a mixed-methods approach to generate location-specific evidence from Diobu. It incorporates residents, landowners, planners, and policymakers, providing a more inclusive understanding of the socio-economic impacts. The study further evaluates current urban planning policies and zoning enforcement, exposing institutional weaknesses and recommending practical reforms. By combining empirical data with theoretical insights, the research provides a comprehensive and context-specific analysis of residential land use conversion in Diobu—addressing both the academic and policy gaps identified in the literature.

IV. MATERIALS AND METHODS

The methodology for this study on residential land use conversion in Diobu, Port Harcourt, Rivers State, Nigeria, employed a mixed-methods approach, combining both qualitative and quantitative research techniques to provide a comprehensive understanding of the phenomenon. The following detailed steps outlined the methodology:

3.1 Research Design

This study adopted a descriptive research design to explore the dynamics of residential land use conversion in Diobu. The descriptive design allowed for an in-depth investigation of the factors influencing land use changes, their socio-economic impacts, and the community's response to these transformations.

3.2 Population and Sample

The target population for this study included residents, landowners, urban planners, government officials, and real estate developers within the Diobu area. To capture a diverse range of perspectives, a stratified random sampling technique was employed to select participants from various stakeholder

groups. The sample size was determined using a confidence level of 95% and a margin of error of 5%, ensuring the findings were representative of the population (Cuesta et al., 2012).

3.3 Data Collection Methods

The study used both primary and secondary data collection methods:

1. Primary Data:

- i. Surveys/Questionnaires: A structured questionnaire was designed to collect quantitative data from residents, landowners, and local business owners. The questions focused on their experiences with residential land use conversion, perceived impacts on housing affordability, community cohesion, and the economic implications of land use changes.
- ii. Interviews: Semi-structured interviews were conducted with key informants, such as urban planners, government officials, real estate developers, and local leaders. These interviews provided qualitative insights into the regulatory and policy frameworks surrounding land use conversion, the drivers behind these changes, and the long-term implications for urban planning in Diobu.
- iii. Focus Group Discussions: Focus group discussions were held with community members to gauge the collective perceptions and concerns regarding land use changes, social impacts, and the adequacy of existing urban planning policies.

2. Secondary Data:

- i. Review of Relevant Literature: Existing academic literature, government reports, and policy documents related to land use conversion, urbanization, and housing were reviewed to contextualize the findings within broader urban planning and development trends.

- ii. Analysis of Historical Land Use Data: Historical data on land use patterns in Diobu were obtained from local government planning departments, land registries, and satellite imagery. This data helped track the evolution of land use over time and identify trends in residential land use conversion.

Ethical approval was sought from a relevant ethics review board prior to data collection. Informed consent was obtained from all participants, ensuring they were aware of the purpose of the study, their right to confidentiality, and their voluntary participation. All personal information and responses were kept confidential, and participants were assured that their participation would not affect their relationship with local authorities or any other institutions.

3.4 Data Analysis

The data collected through surveys were analyzed using descriptive and inferential statistical techniques. Descriptive statistics (such as frequencies, percentages, means, and rank values) were used to summarize the demographic characteristics of the respondents and their views on land use conversion. A rank value rating scale was applied to determine the relative importance, severity, or frequency of the identified drivers, impacts, and perceptions of land use conversion. This ranking approach enabled the study to prioritize respondents' assessments and clearly identify variables that exerted the greatest influence on residential land use conversion in Diobu.

The qualitative data from interviews and focus group discussions were analyzed using thematic analysis. Transcriptions were coded manually to identify key themes and patterns related to the drivers, impacts, and policy responses to land use conversion. Thematic analysis helped uncover underlying narratives and provided a deeper understanding of the socio-cultural and economic dimensions of land use change.

This methodology combined both quantitative and qualitative techniques to provide a holistic understanding of residential land use conversion in

Diobu. By employing surveys, interviews, focus group discussions, and secondary data analysis, the study aimed to capture both the statistical trends and the lived experiences of those affected by land use changes, offering valuable insights for urban planning and policy development.

V. RESULTS AND DISCUSSION

Based on the methodology described, the findings from 300 respondents and 20 key informants are presented below:

Table 1: Drivers of Land Use Conversion (Ranked by Mean Score)

Table 1 show that economic pressures emerged as the strongest driver (Mean=4.5), indicating profit motives significantly fuel conversions. Rapid urbanization (Mean=4.2) highlights population growth as a key stressor. Regulatory weakness (Mean=3.9) suggests enforcement gaps enable unplanned changes, while evolving community needs (Mean=3.6) reflect demand for mixed-use spaces. Key informants described a "profit-over-planning" culture, where developers capitalize on weak oversight, confirming that market incentives and lax enforcement are primary enablers of conversion.

Table 2: Socio-Economic Impacts (Ranked by Severity)

Table 2 show that Housing availability is the most severe impact (Mean=4.6), directly affecting affordability. Infrastructure demands (Mean=4.3)

indicate systemic strain from increased commercial activity. Reduced community cohesion (Mean=4.0) points to social fragmentation, while livelihoods (Mean=3.8) show uneven economic benefits, often displacing residents. Residents expressed a "loss of home and community," noting that conversions disrupt social networks and prioritize commercial gain over residential stability, exacerbating displacement and infrastructure overload.

Table 3: Effectiveness of Policy Interventions (Ranked by Perceived Effectiveness)

Table 3 show that All policy areas scored low (Means ≤ 3.0), indicating systemic failure. Infrastructure development (Mean=3.0) is seen slightly more effective than zoning enforcement (Mean=2.8). Affordable housing policies (Mean=2.3) are deemed highly ineffective, highlighting a critical governance gap. Planners admitted to "reactive, not proactive, enforcement," revealing institutional incapacity to implement or prioritize affordable housing, leading to unchecked commercial encroachment.

Table 4 show that Strong consensus exists on negative housing impacts (Mean=4.4). High support for policy change (Mean=4.1) reflects community demand for intervention. Mixed views on economic benefits (Mean=3.7) show recognition of growth but concern over inequitable distribution. Residents voiced a "desire for balanced development," acknowledging economic potential but stressing

urgent need for inclusive policies to protect housing and ensure equitable benefits.

4.1 Discussion of Findings Drivers of Residential Land Use Conversion

The findings on the drivers of residential land use conversion highlight the complex interplay of factors that lead to land use changes in Diobu. Key drivers identified include rapid urbanization, economic pressures, regulatory weaknesses, and evolving community needs.

- i. **Rapid Urbanization:** The high demand for land due to population growth and the influx of people into Diobu has created pressure on existing residential areas, with 78% of respondents identifying it as a key driver (Mean=4.2). As Diobu continues to urbanize, residential spaces are increasingly being repurposed to accommodate the growing population and its diverse needs. This finding aligns with studies that have shown how rapid urbanization often triggers land use changes, particularly in cities experiencing population growth (Russell-Smith et al., 2018; Nwokaeze & Uchendu, 2025).
- ii. **Economic Pressures:** The conversion of residential land for commercial use can be seen as an economic strategy driven by the potential for higher profits from mixed-use and commercial developments, ranking as the strongest driver (Mean=4.5, 85% frequency). This economic imperative is evident in many urban areas globally, where developers are motivated by market demands. The findings in Diobu echo similar patterns observed in other Nigerian cities where real estate development is often driven by the need for higher returns on investment (Mannan, 2024), reflecting Stull's (1974) theory on market-driven land use shifts.
- iii. **Regulatory Weaknesses:** The study highlights how ineffective enforcement of zoning laws and urban planning regulations (Mean=3.9) contributes to the unregulated conversion of

residential land. This lack of regulation is a common challenge in rapidly growing cities, where urban planning is often reactive rather than proactive. As noted in the literature, weak land governance and poor regulatory frameworks frequently lead to land use violations and unsustainable urban development (Nguyen, Agbola & Choi, 2019).

- iv. **Community Needs:** The demand for mixed-use spaces, where residential, commercial, and social activities coexist, is increasing (Mean=3.6). This reflects changing lifestyles and preferences within Diobu's community, particularly as more residents seek convenient access to work, services, and amenities. The findings point to a growing demand for flexible spaces that can serve multiple functions, a trend supported by Raman and Roy's (2019) Mixed Land Use Planning Theory, which explains the natural evolution of dense urban areas toward mixed uses.

Socio-Economic Impacts of Residential Land Use Conversion

The findings on the socio-economic impacts highlight several critical issues arising from land use conversion, including housing availability and affordability, community cohesion, livelihoods, and infrastructure demands.

- i. **Housing Availability and Affordability:** The reduction in the supply of residential land due to conversions is resulting in increased housing costs and a shortage of affordable housing for low-income residents, identified as the most severe impact (Mean=4.6, 88%). This is a significant concern, as many urban areas worldwide face similar challenges, with the conversion of residential land contributing to housing inequality (Ikiriko & Gbarabe, 2024). The findings suggest that land use conversions in Diobu are exacerbating spatial inequities, particularly for vulnerable groups, and increasing the burden on the lower-income population.

- ii. **Community Cohesion:** The study indicates that residential land use conversion is weakening social ties within neighborhoods (Mean=4.0). This is a common consequence of urban commercialization, as residential areas become dominated by businesses, leading to a decline in community interaction and cohesion (Onwuanyi & Oyetunji, 2021). The loss of a sense of community can negatively affect residents' quality of life, making neighborhoods feel less cohesive and more fragmented.
- iii. **Livelihoods:** While some landowners and developers benefit from increased property values and commercial rents, many residents face displacement or the loss of affordable housing options (Mean=3.8). This dichotomy highlights the uneven distribution of benefits and burdens that result from land use changes, with lower-income groups often bearing the brunt of these transformations. The findings support the argument that land use conversion can lead to gentrification, where wealthier residents and businesses replace the original population, displacing poorer residents (Ibrahim, 2022).
- iv. **Infrastructure Demands:** The increased commercial activities resulting from land use conversion place additional stress on existing infrastructure, such as roads, utilities, and public transportation systems (Mean=4.3). This strain is particularly evident in Diobu, where infrastructure development has not kept pace with the rapid urban growth (Ayo-Odifiri et al., 2021). The findings point to a need for better integration of land use planning with infrastructure development, a theme echoed in many studies on urban sustainability.
- i. **Weak Enforcement of Zoning Laws:** The lack of effective enforcement of zoning and land use regulations (Mean=2.8) has contributed to the proliferation of illegal land use conversions. As the findings suggest, this gap in policy enforcement allows residential areas to be converted without adequate oversight, leading to uncontrolled urban sprawl and the loss of residential spaces. This is a common issue in developing cities where regulatory frameworks often lag behind the pace of urban growth (Obinna et al., 2009).
- ii. **Lack of Affordable Housing Policies:** The absence of policies aimed at protecting residential land for affordable housing has made it easier for developers to convert residential areas into commercial spaces, with this policy area deemed the least effective (Mean=2.3). This finding underscores the need for comprehensive urban planning policies that prioritize the preservation of residential areas and the development of affordable housing projects, as discussed in the literature (Umeh & Ezeji, 2023; Zakari, 2022).
- iii. **Inadequate Infrastructure Planning:** The failure to adequately plan for infrastructure needs in the face of land use conversions is evident in the study's findings, though it was perceived as slightly more effective than other areas (Mean=3.0). The increased pressure on roads, utilities, and transportation networks highlights the gap in policy coordination between land use management and infrastructure development. This issue has been noted in other studies on urban planning, where infrastructure often fails to meet the demands of rapidly urbanizing areas (Izeogu, 2018).

Effectiveness of Policy Interventions

The findings on policy interventions indicate that the current regulatory framework for managing land use conversions in Diobu is ineffective in addressing the challenges posed by rapid urban growth, with all policy areas scoring low (Means ≤ 3.0).

Community Perceptions of Residential Land Use Conversion

The findings on community perceptions reveal that most residents view residential land use conversion

negatively, primarily due to its adverse impacts on housing and community cohesion.

- i. **Negative Impact on Housing:** The perception that residential land use conversion leads to a loss of affordable housing is widely shared among residents (Mean=4.4, 82%), who are concerned about being displaced by rising rents and property values. This is consistent with the findings of studies on gentrification and urban redevelopment, where the displacement of low-income residents is a major concern (Ikiriko & Gbarabe, 2024).
- ii. **Mixed Views on Economic Benefits:** While some residents acknowledge the economic growth associated with land use conversion, the majority express concerns about the unequal distribution of these benefits (Mean=3.7). The findings suggest that while developers and landowners benefit financially, local residents may suffer from higher living costs and reduced access to affordable housing, reflecting the uneven outcomes highlighted in the theoretical frameworks of land value (Topcu & Kubat, 2009) and market-driven conversion.
- iii. **Support for Policy Change:** The study finds that a significant portion of the community supports stronger regulations and policies to control land use conversion (Mean=4.1). This finding highlights the need for urban planners and policymakers to engage with local communities in designing policies that balance economic development with social equity, an approach emphasized in the literature on integrated and participatory planning (Zakari, 2022).

Summary of Findings

The discussion ties together the key findings of the study, emphasizing the need for more robust urban planning policies and regulations to address the challenges posed by residential land use conversion in Diobu. It suggests that while economic growth is a positive outcome of land use conversion, the socio-

economic costs, particularly in terms of housing affordability and community cohesion, are significant. The findings call for the development of policies that prioritize sustainable urban growth, protect affordable housing, and ensure that land use changes do not disproportionately affect vulnerable communities.

VI. CONCLUSION

This study has explored the dynamics of residential land use conversion in Diobu, Port Harcourt, Rivers State, Nigeria, focusing on the key drivers, socio-economic impacts, and the role of policy in managing these transformations. The findings demonstrate that residential land use conversion in Diobu is primarily driven by rapid urbanization, economic pressures, ineffective regulatory frameworks, and changing community needs. These transformations have significant socio-economic implications, including housing shortages, rising costs, displacement of lower-income residents, weakened community cohesion, and increased strain on infrastructure.

Moreover, the study reveals that existing urban planning policies and regulatory frameworks are insufficient to manage these land use changes effectively. The lack of strong enforcement mechanisms for zoning laws and the absence of policies that prioritize affordable housing have exacerbated the negative consequences of residential land use conversions. In conclusion, while land use conversion can contribute to urban growth and economic development, the associated challenges require urgent attention. A comprehensive and sustainable urban planning approach is needed to balance economic interests with the social and environmental needs of the community.

Based on the findings of this study, the following recommendations are proposed for managing residential land use conversion in Diobu, Port Harcourt, and similar urban areas:

1. **Strengthen Regulatory Enforcement:** Implement rigorous, proactive monitoring and enforcement of zoning laws with clear penalties for violations. Establish regular land

audits to track conversions, ensuring all developments align with a revised, community-centric master plan that protects residential zones from unplanned commercial encroachment.

2. Prioritize Affordable Housing: Enact and fund policies mandating the inclusion of affordable housing units in new developments. Create public-private partnerships and provide incentives for developers to preserve and construct low-cost housing, directly addressing the critical shortage and displacement revealed by the findings.
3. Adopt Integrated Infrastructure Planning: Mandate that all land-use approvals are contingent on concurrent infrastructure impact assessments and upgrade plans. Develop and fund a strategic infrastructure investment program synchronized with urban growth projections to prevent the systemic overload of roads, utilities, and public services.
4. Institutionalize Community-Led Planning: Formalize mandatory community consultation and participatory decision-making processes in urban planning. Launch public awareness campaigns on land rights and zoning, empowering residents to co-design developments that balance economic opportunity with social equity and community cohesion.
